ABOUT RESOURCE PERSON

Mr. Sanjay Tandon formed and set up the Indian Singers Rights Association (ISRA) which was the 1st Copyright Society to be registered in India. He was instrumental in strengthening the Indian Performing Right Society Limited, (IPRS) – the Music Royalty Collecting Society of India. He pioneered the Movement of Copyright Administration in India and developed the IPRS from scratch to an internationally recognized entity. He was and is very closely involved with the Copyright Movement in India and abroad. He worked as a Leading Copyright Consultant from July 2004 to September 2005 to the likes of Lata Mangeshkar, Asha Bhosle, Javed Akhtar, Sonu Nigam, Sunidhi Chauhan, Shaan, and such other 103 top Artists. He was Head at Mobile Content Alliances, Reliance Communications Ltd, from October 2005 to March 2008. He was closely associated with the latest 2012 copyright amendments in India and as an expert on the subject of copyright, deposed and submitted his recommendations before the Joint Parliamentary Committee on the Amendments. He was Vice-President at Reliance Entertainment from April 2008 till January 2013 steering Reliance Group's Anti-Piracy Operations be it in whatever format – Physical, Cable or the Internet. From February, 2013 till June, 2017, he was the CEO of the Music Composers' Association of India (MCAI), the body which represents the Composers of India and at present, he is one of the Directors and CEO of the Singers' Association of India (SAI) and of the Indian Singers' Rights Association (ISRA).
